### **16. INSURANCE**

By endorsing the application form for entry, the FMN of the rider certifies that the rider is insured in accordance with the FIM requirements.

All entries hold UAM licence or their equivalent CONU or FIM licence & Start Permission letter address to ACME from their Federation (FMN) starting the Riders name, date of birth and that the Rider is in possession of FIM insurance

The organizer has contracted a third party insurance in accordance with Art. 110.1 of the FIM Sporting Code.

### **17. PROTESTS AND APPEALS**

Any person or group of persons (rider, entrant, manufacturer, official, etc.), recognised by the FIM and concerned by a decision taken under the authority of the FIM, may ask for redress for the consequences of that decision.

Protests must be lodged according to the FIM Disciplinary and Arbitration Code and the Supplementary Regulations and be accompanied by a fee of

US\$ 100.-or the equivalent amount in local currency, returnable if the protest is justified.

Generally, protests against the eligibility of a rider, entrant or a motorcycle entered, must be made before the start of the official practice.

Protests against results must be presented to the International Jury within 30 minutes following the announcement of the results.

An appeal may be made against a decision of the International Jury to the International Disciplinary Court (CDI).

If the protest entails dismantling a motorcycle, the protest fee must be accompanied by an additional deposit of US\$ 150.– ( $\leq$ 120.–). This fee must be paid by the losing party to the mechanic of the rider who had to open the engine.

Protests entailing a fuel control must be accompanied by an additional deposit of US\$ 1'000.- ( $\in 800.-$ ).

### **19. ADVERTISING**



Advertising is permitted on the paddock, body of motorcycle, helmet, rider accessory in case of not interfering with the security of the event, publication of result and advertising of the organizer. The participant teams who are accept the Organizer's advertising must reserve a space on front splashboard of the motorcycle.



# MAP OF EAST JAVA






# **CITY MAP OF JEMBER**
